2020 Corvette Stingray Z51 Coupe – 6.2L V8 DI Engine – Limited Production

1. “Win Derek’s 2020 Chevy Corvette Stingray Z51” promotional giveaway is a joint casino promotion for gaming patrons of the D Las Vegas and the Golden Gate Hotel & Casino. The promotion runs from January 1, 2020 until November 14, 2020 with ten (10) monthly qualifier drawings one (1) each month January - October. The grand prize 2020 Chevy Corvette Stingray Z51 giveaway is Saturday, November 14, 2020.
2. Club One Players Club members earn drawing entries as follows:
 - a. One (1) drawing entry for every 100 points earned playing slots or video poker.
